

## Backup power for the parish's pump stations

### **About Generators**

It's never too early to start planning, and as the 2015 hurricane season approaches, the Baton Rouge SSO Program is pleased that over half of the standby generators, designed to keep wastewater flowing to treatment facilities in storm events and power outages, are on location and functioning, and the remaindercontinue to be installed parish-wide.

Generators are placed at pump stations so that during power outages the generators are able to provide power to the pump stations. This allows the stations to continue to move wastewater to the plants, preventing sewer overflows.

### Benefits of Generators

Generators will aid in preventing backups in homes, businesses, streets, and private property. The system has proven widely successful across the Parish so far during power outages and small weather events. The Program Team is enthusiastic to see the benefits of this system as the project reaches completion, and are confident that the efforts made on this project will be an advantage to all.



# LOOKING AHEAD...

The following projects are expected to advertise for construction bids in the upcoming months.

East Blvd - Government St. Area Rehabilitation Project (12-AR-MS-0041): This rehabilitation project consists of correcting defects in the system.

Airline Hwy Pipeline Project Group A (10-GS-MS-007A): This capacity project involves upsizing 4,520 LF of gravity main ranging between 8 and 24 in. in diameter and constructing 23,450 LF of force main ranging between 36 and 48 in. in diameter.

Airline Hwy Pipeline Project Group B (10-GS-MS-007B): This capacity project includes the installation of approximately 28,000 LF of gravity main ranging between 8 and 42 in. in diameter and approximately 50 LF force main in the south gravity central basin to increase sanitary sewer capacity. This project will also include approximately 1,000 LF of Jacked and Bored pipe ranging between 24 and 60 in. in diameter.

Zachary Area Transmission Network Improvements Project Phase 5 (o6-WC-IF-o14E): The project will replace a pump station and improve piping. The new pump station will be able to hand a peak wet weather flow of 3,380 qpm.

Sherwood Forest Blvd- Goodwood Blvd Sewer Area Upgrades (11-FM-MS-0005): This capacity project involves upsizing 14,760 LF of gravity main ranging between 8 and 36 in. in diameter and constructing 15,780 LF of force main ranging between 8 and 18 in. in diameter.
