

## **Program Management**



The Baton Rouge Sanitary Sewer Overflow (SSO) Program is a comprehensive sewer infrastructure improvement project. The program involves implementing the design and construction of projects to rehabilitate sewer pipelines, improve or install new pump stations, increase storage capacity, and upgrade facilities at the North and South Wastewater Treatment Plants (WWTPs).

### Parishwide SSO Program Projects Improve Quality of Life for Residents

Rehabilitation projects will improve more than 5,500,000 linear feet (If) of gravity sewer pipe (1,042 miles) and 20,000 manholes.

Three treatment plant projects at the South WWTP will increase capacity to handle increased flows during and after storm events.

Capacity projects include upgrades or installation of 152 pump stations and improvements to 350,000 lf of gravity sewer (66 miles) and 670,000 lf forcemain (127 miles).

Three collection system wet weather storage projects involve adding 20 million gallons (MGs) of storage in the Zachary Area Transmission Network; 26 MG of storage, 25,000 lf of forcemain and three pump stations at the Choctaw Storage and Pump Station Facility; 56 MG of storage in the North WWTP basin; and 10 MG of storage at Hooper Road.



# In the Spotlight...

## Promoting Local, Small, and Disadvantaged Businesses

The Office of the Mayor-President, the Department of Public Works (DPW), and the SSO Program Management Team are working in partnership to strengthen local business capacity and encourage participation on Program projects. SSO Program staff routinely meets with small and disadvantaged businesses in Baton Rouge who are interested in providing services and participating on the Program. Business owners are provided information on Program contractors, upcoming projects, registering with the City-Parish's database, and available support and resources. Program staff also assists business owners in developing capabilities statements and provide instructions on how to access solicitations for services through RFQ Manager (for Design Consultants) and BIDX (for Contractors).

#### **Registering to Receive RFQs**

As new Request for Qualifications (RFQs) are advertised through the Advocate newspaper, Design Consultants can subscribe to the RFQ Manager and receive notices when new DPW projects are available to receive RFQs.

To submit the RFQ, follow the directions in the Public Notice, using the allotted forms for the Statement of Qualification, before or by the specified deadline.

#### **Registering to Receive Construction Advertisements**

Construction Contractors registering through BIDX should log-on to the online bidding exchange web site at <a href="https://www.bidx.com">www.bidx.com</a>.

- Establish your account with a valid username and password (note there is a monthly fee involved). Alternately, paper copies of the SSO project plans, specifications, and contract documents are on file at DPW and may be obtained upon payment of the designated fee.
- 2. Understand the construction project being advertised, including pre-bid meeting date and bid due date.
- Attend a mandatory pre-bid conference held at the date and time described in the Notice to Contractors.
- 4. Submit electronic bids and electronic bonds through www.bidx.com or in person at DPW Purchasing Department prior to the bidding deadline.

#### Projects Recently Advertised for Construction Bids

The following projects advertised for construction bids in April 2011:

Bluebonnet Blvd - Jefferson Highway Phase 2 Comprehensive Rehabilitation Project. Estimated Construction Cost - \$6,685,000. Advertised April 29, 2011; Mandatory Pre-Bid Meeting May 16, 2011; Construction Bids Due May 24, 2011.

Central Consolidation Pump Station 42 Forcemain Capacity Improvement Project Phase A. Estimated Construction Cost - \$16,610,000. Advertised April 29, 2011; Mandatory Pre-Bid Meeting May 18, 2011; Construction Bids Due June 2, 2011.

Perkins/Old Perkins Area - BPS 514 Improvements Capacity Improvement Project.

Estimated Construction Cost - \$10,397,000. Advertised April 8, 2011; Mandatory Pre-Bid Meeting April 26, 2011; Construction Bids Due May 10, 2011.

#### Projects to be Advertised for Engineering Selection:

Plank Road Pump Station Capacity Improvement Project

Estimated Construction Cost - \$9,300,000. This project consists of replacing five and upgrading three pump stations. Expected to advertise for RFQ in May 2011.

#### Multiple PS – Burbank Drive – Siegen Lane Capacity Improvement Project

Estimated Construction Cost - \$4,100,000. The project includes replacement of six pump stations. The new pump stations will work in conjunction with the forcemain upgrades in other South Forced Lower Basin projects to alleviate chronic SSOs at and near these pump stations. Expected to advertise for RFQ in May 2011.

#### Oak Villa Bvd - Monterey Blvd Capacity Improvement Project

Estimated Construction Cost - \$9,000,000. This project includes the upsizing of the gravity sewer upstream of PS16, PS50, and PS51 and the forcemain from PS16, which is being upgraded as part of the Multiple PS – Florida Blvd – Sherwood Forest Blvd project. Expected to advertise for RFQ in May 2011.

#### Joor Road – Greenwell Springs Capacity Improvement Project

Estimated Construction Cost - \$6,900,000. This project involves the design and construction of forcemain upgrades in the North Forced West Basin. The upgrades are designed to alleviate chronic SSOs at the pump stations and increase the forcemain capacity. The upgrades range in size from 6 to 24 inches in diameter. Expected to advertise for RFQ in May 2011.
