The Sanitary Sewer Overflow (SSO) Program is improving the City of Baton Rouge/ East Baton Rouge Parish's wastewater infrastructure, contributing to meeting important Consent Decree requirements and preparing a solid foundation for future growth in the Parish. In addition to following sound engineering and construction practices, several other priority components contributing to project success include field safety, supporting and encouraging local business participation, public education, and construction communication outreach.

Promoting field safety forms the basis for field activities related to the SSO Program. Staff conduct safety audits on construction projects to confirm that contractors, subcontractors, inspectors, and construction managers comply with program safety guidelines. Encouraging local participation and building

business capacity are unwavering program priorities. Program staff routinely meets with local small and disadvantaged businesses to discuss program opportunities, help them network with program contractors and design firms, and contracting with local companies. The SSO Program is also implementing capacity building programs including a Mentor-Protégé program and a Land Acquisition Apprentice program.

Increasing community awareness concerning SSOs is an essential part of helping our community maintain our infrastructure and reduce overflows that can result in sewer backups in our homes. SSO program staff routinely present information on reducing and reporting SSOs at community meetings and events throughout East Baton Rouge Parish.

Communicating during construction is critical to inform residents and business owners of construction impacts and road closures. In addition to speaking at community events and distributing fact sheets and notices to residents, the communication team works closely with the City/Parish's 311 system to provide timely responses to community questions through a SSO program hotline (225.588.5678).

South Wastewater Treatment Plant Wet Weather Improvements Phase I Project


The South Wastewater Treatment Plant is one of three critical treatment plants in the East Baton Rouge Parish system. There are three important SSO Program projects that involve upgrading and rehabilitating this facility. One of these projects, the Wet Weather Improvements Phase 1 Project, will provide increased storage capacity and will improve operations at the plant. This project involves the addition of 66 million gallons of storage (in four new tanks) and improvements to plant equipment.

Approximately 400 miles (or the distance from Baton Rouge to Birmingham) of rebar was used as part of this project.

- Elm Grove Garden Road Harding Blvd: This rehabilitation project involves rehabilitating approximately 199,500 linear feet of gravity main and 839 manholes.
- Group Project 2 Small Pump Stations: This capacity improvement project involves replacing seven pump stations that will work in conjunction with the forcemain upgrades in other South Forced Lower Basin projects.
- Oak Villa Blvd Choctaw Street: This rehabilitation project involves inspecting and rehabilitating, as needed, approximately 245,000 linear feet of forcemain and 990 manholes.
- Highland Road Buchanan Street: This capacity improvement project involves upgrading approximately 4,465 linear feet of forcemain and 8,390 linear feet of gravity main.
- Foster Drive Government Street (Phase A): This rehabilitation project involves replacing and rehabilitating 629 manholes and improvements to 80,600 linear feet of gravity main.

6. Nicholson Drive – Highland Rd – Perkins Rd (Phase A):

This capacity project involves upgrades to approximately 8,400 linear feet of forcemain, 3,400 linear feet of gravity main, and the rehabilitation/replacement of 20 manholes.

- Citiplace/Essen Area PS119 and Forcemain Improvements: This capacity project involves replacing one pump station and upgrading approximately 8,100 linear feet of forcemain.
- South Blvd-St. Joseph St/25th Street N. Acadian Thruway: This capacity improvement project involves upgrading approximately 18,360 linear feet of forcemain and 3,000 linear feet of gravity main.
- 9. Foster Drive Government Street (Phase B): This rehabilitation project involves upgrading approximately 78,700 linear feet of gravity main.
- 10. Capitol Lake Dr Gayosa St/25th Street N. Acadian Thruway: This capacity improvement project involves upgrading approximately 19,320 linear feet of forcemain and 19,150 linear feet of gravity main.
- **11. Downtown Area Pump Station Improvements:** This capacity project involves upgrading three pump stations.
- **12.Bluebonnet Blvd Jefferson Hwy Phase 1:** This rehabilitation project involves rehabilitating approximately 54,200 linear feet of gravity main.
- **13.Kenilworth Blvd Boone Drive:** This rehabilitation project involves rehabilitating approximately 72,000 linear feet of gravity main and 1,159 manholes.
- **14.Sharp Road Florida Blvd:** This rehabilitation project involves rehabilitating approximately 274,475 linear feet of gravity main and 1,154 manholes.

15.Bluebonnet Blvd – Jefferson Hwy Phase 2: This rehabilitation project involves rehabilitating approximately 63,100 linear feet of gravity main.

16.Silverleaf Road – Ford Street: This rehabilitation project involves implementing upgrades to 115,200 linear feet of gravity main.

17.Multiple PS – Jefferson Hwy – Park Forest Drive: This capacity project involves upgrading six pump stations.

18.Brookstown Road – Evangeline Street (Phase 2): Phase 2 of this rehabilitation project involves rehabilitating approximately 84,000 linear feet of gravity main and 1,075 manholes.

19. Brookstown Road – Evangeline Street (Phase 1):

This rehabilitation project involves rehabilitating approximately 161,000 linear feet of gravity main and 1,150 manholes.

20. Highland Road – Burbank Drive: This capacity project involves upgrading approximately 39,400 linear feet of forcemain.

21.Zachary Area Transmission Network (Phase 4): Phase 4 of this capacity project will upgrade approximately 42,500 linear feet of forcemain.

22.Group Project 1A (Veterans Parkway – Gravity Mains): This capacity project involves upgrading approximately 46,000 linear feet of gravity main.

- 23.Choctaw Storage and PS Facility: This WWTP project involves replacing three pump stations and implementing improvements to approximately 25,000 linear feet of forcemain.
- 24.SWWTP Wet Weather Improvements (Phase 1): Phase 1 will provide wet weather storage, influent pumping, and preliminary treatment at the SWWTP.

25.Central Consolidation – PS42 Forcemain – Phase A: This capacity project involves upgrading one pump station and approximately 32,000 linear feet of forcemain.

26.Perkins/Old Perkins Area – Booster PS 514 Improvements: This capacity improvement project involves upgrades to one booster pump station.







- 27.Zachary Area Transmission Network (Phase 1): Phase 1 will involve upgrading three pump stations.
- 28.Zachary Area Transmission Network (Phase 3):

Phase 3 of this capacity project will improve approximately 27,000 linear feet of forcemain.

- 29.Staring Lane Forcemain (Phase 2 Highland to Perkins): This capacity project involves upgrading approximately 12,363 linear feet of forcemain.
- **30.Emergency Generators Purchasing:** This project involves purchasing generators at each of the pump stations in East Baton Rouge Parish to ensure continuity of service during power failures.
- **31.Emergency Generators Installation:** This project involves installing generators at each of the pump stations in East Baton Rouge Parish to ensure continuity of service during power failures.
- 32.Staring Lane FM (PH III Perkins to PS58): This capacity project will improve approximately 10,200 linear feet of forcemain.
- **33.Bayou Duplantier Area Sewer Upgrades:** This capacity project will improve approximately 12,600 linear feet of forcemain.
- **34.Stanford Avenue Morning Glory Road:** This rehabilitation project involves rehabilitating approximately 55,600 linear feet of gravity main and 704 manholes.
- **35.EPA SCADA:** Supervisory Control and Data Acquisition will be installed to provide central collection, storage and processing of data from the WWTPs and the collection system.
- **36.Central Consolidated Pump Stations (2,3,4,5,6,7,10,91 and Southdowns):** This project involves the design and construction of nine pump stations, three of which (PS2, PS7, and PS10) will be interconnected and will discharge into PS5. PS5 will pump directly to the South WWTP via a new large forcemain following completion of construction of the South WWTP Phase I project.
- **37.Annual Parish Wide Physical Inspection:** This project involves cleaning, smoke testing, and CCTV inspection of sewer pipes and manholes throughout the parish.
- **38.SWWTP Wet Weather Improvements Phase 2:** This project involves expanding the SWWTP to accommodate a peak flow of 200MGD. Additionally, wet weather improvements within the treatment process will be made.
- **39.Acadian Thruway Claycut Road:** This rehabilitation project involves rehabilitating approximately 76,000 linear feet of gravity main and 712 manholes.
- **40.Acadian Thruway Perkins Road:** This rehabilitation project involves rehabilitating approximately 36,900 linear feet of gravity main and 517manholes.
